# Release and Hold Harmless Agreement

I understand and assume the possible risks inherent to all dog-related activities, including, but not limited to, bodily injury to myself, damage to my property and my dog, or bodily injury and damage to property of any person accompanying me to the seminars and training classes, including private training classes, offered by Central Vermont Humane Society, Inc., a Vermont nonprofit corporation ("CVHS"), at any location where seminars and training classes, including private training classes (individually, a "Training Session" and collectively, the "Training Sessions"), are offered, including, but not limited to, the premises located at 1589 Rte. 14 S. East Montpelier, Vermont. I further understand that this Release and Hold Harmless Agreement has no time limitation and will remain in full force and effect as long as I participate in any of the Training Sessions by CVHS, regardless of the location of such Training Session and regardless of what dog I am training.

Therefore, in consideration of the privilege of training my dog with or through CVHS, I do hereby agree to hold harmless and indemnify CVHS, its members and agents, including any and all persons who will be conducting the Training Sessions, and the owners of any location where such the Training Sessions are held (collectively, the "Covered Persons"), of and from any claim for damages, including property damage, and/or injuries I might sustain while participating in any of the Training Sessions, and further release CVHS and Covered Persons from any liability or responsibility for any accident, damage, injury, or illness to me or to any dog owned by me, or to any family member, spectator or guest accompanying me on the premises where any of the Training Sessions is held, even if such liability may arise out of negligence or carelessness of CVHS and/or the Covered Persons. I understand that the training premises as used in this Release and Hold Harmless Agreement shall include any location where any of the Training Sessions are held, including, but not limited to, the premises located at 1589 Rte. 14 S. East Montpelier, Vermont.

CVHS makes no representation, guarantees or promises, implied or expressed, that any training received from CVHS will eliminate dangerous propensities that a dog may possess. I fully understand that regardless of the training received by the animal, a dog always possesses the propensity to bite. I hereby agree to indemnify and hold harmless CVHS and the Covered Persons from any and all claims by any person that arise of any action by any dog, including my own, that participated in a Training Session, even if such claims arise out of negligence or carelessness of CVHS and/or the Covered Persons.

I affirm and have proof that my dog is current on all vaccinations appropriate for my dog. I agree to abide by all the rules presented to me at a Training Session. I hereby agree to the terms of the above Release and Hold Harmless Agreement as it pertains to any minor child accompanying me to these training courses and participating in same.
